## What's been happening on site

- Currently 113 wind turbines operational.
- Several turbines down due to blade damage
- Niagara Road culverts now have temporary props to facilitate heavy loads so we expect to return turbines to service once parts are delivered to site.
- No health and safety issues to report in this period

## Upcoming activities

- Full and partial site outages for HV maintenance – early to mid June – to facilitate construction of the new PLQ transmission line



# COOPERS GAP WIND FARM COMPLIANCE ACTIVITIES



## Environmental Compliance

- GE continue to manage the site in accordance with the environmental management plans.

## Acoustic Compliance

- The first round of acoustic compliance testing has been conducted.
- Results are being assessed by independent acoustic consultants, who have advised the wind farm has demonstrated compliance.
- As required under the Development Approval, a second round of acoustic monitoring will be undertaken.
- Compliance will be confirmed when both rounds of monitoring are complete, results assessed, and submitted to the responsible authority.

### Community Fund

- \$100,000 per year (previously 70/30 split)
- Tilt Renewables will maintain the fund at \$100,000
- Balance outstanding from 2023: \$22,839
- 2024 round to open mid year

**What's happening on-site?**

Coopers Gap Wind Farm moved into official operations in 2023. Over the last 12 months the Project generated over 1500 GWh of clean energy. That is enough to avoid over 1.2 million tonnes of greenhouse gas emissions.

You may have seen some movements to and from site over the last 12 months as our team continued their regular program of proactive maintenance. Significant works on site included the replacement of a generator, two gearboxes and two transformers.
