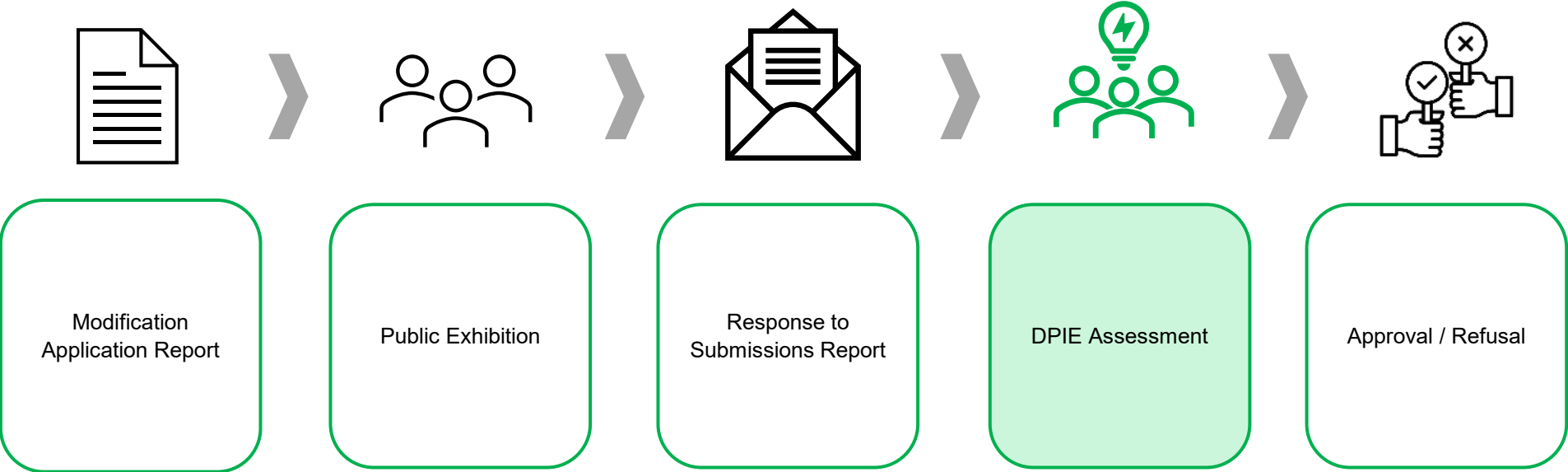

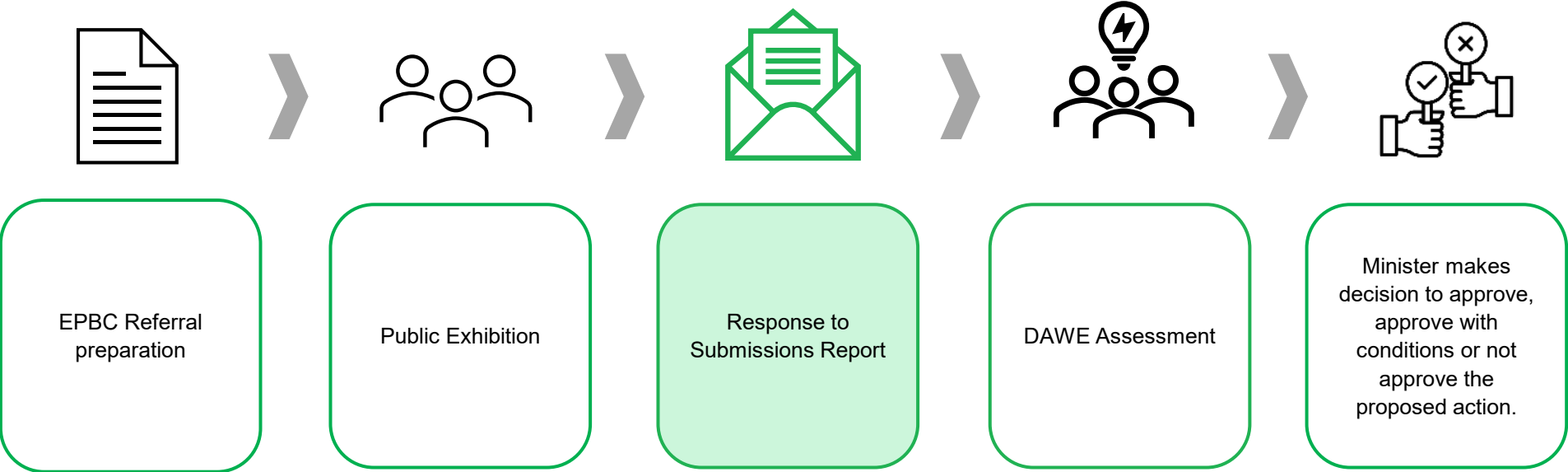

EPBC SUBMISSIONS



Submissions have been received on the EPBC referral and Preliminary Documentation. The following listed species and communities are likely to be impacted:

- White Box Yellow Box Blakely’s Red Gum Grassy Woodland and Derived Native Grassland ecological community
- Superb parrot
- White-throated needletail
- Striped legless lizard
- Golden sun moth

Of the 24 individual submissions received on the project, issues are broadly categorised in the following table.

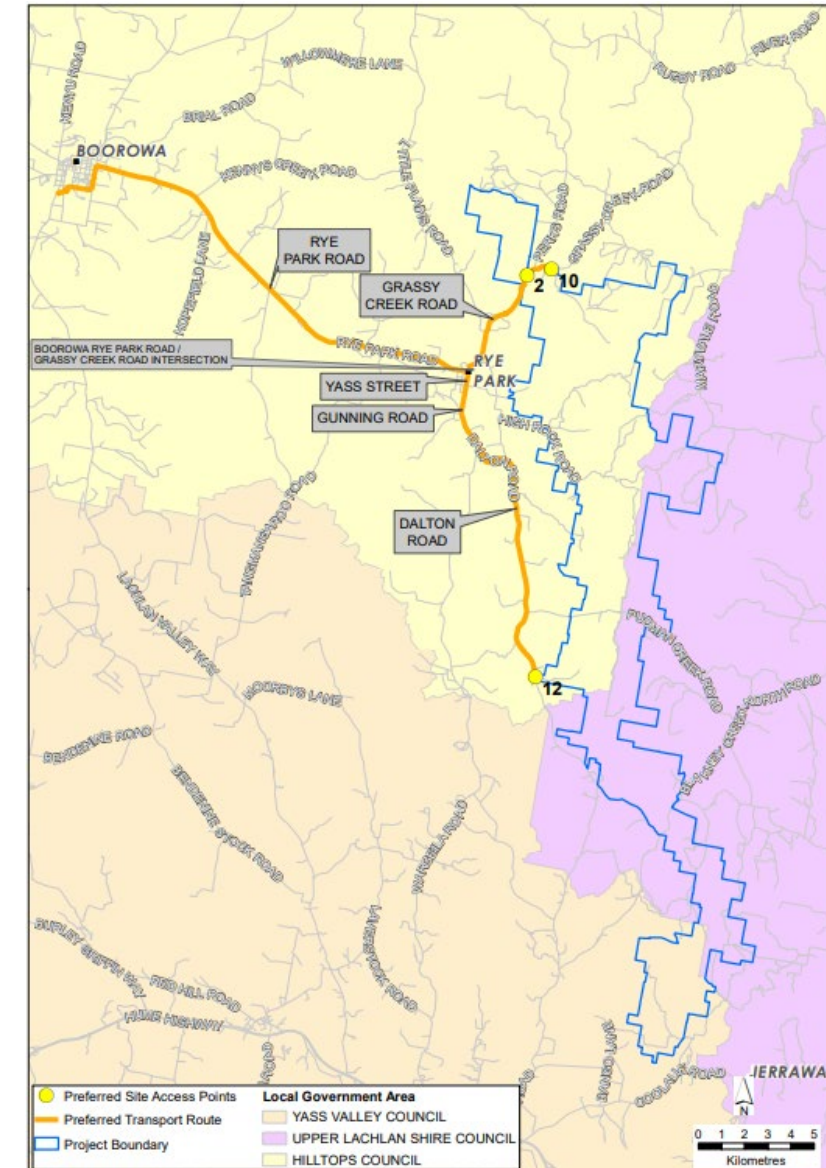
Matters not considered part of the EPBC Referral are assessed and addressed as part of our request to modify State Significant Development Consent SSD-6693 under the EP&A Act. The EPBC RTS document will reference where these issues are addressed in Modification Application, State RTS report and Amendments report.

Procurement

- Key contracts and agreements continue to be progressed with preferred suppliers
- Balance of Plant, WTG Supply and Grid Connection Early Works commenced

Early Works Activities

- Survey of public roads and intersection locations,
- Geotech – Test pits, boreholes and sampling across the site
- Visual Inspections and ground truthing
- Design – Public Road Upgrades, Civil, Electrical and Grid
- Bridge testing/modelling

- Geotech drilling and test pit program to be completed
- Survey on the site
- Detailed designs of infrastructure
- Planning the sequencing of construction
- Finalise the preparation of management plans (e.g. TMP, BBAMP, BMP)
- Prepare Final Layout Plans
- Finalise key contracts

WHAT'S COMING UP



Consultation

- Consultation with key regulatory agencies and stakeholders on the required management plans (e.g. TMP, BMP), required prior to the commencement of construction.
- Affected landowners and neighbours
- Pre-construction community drop-in information session

- We will regularly provide our preferred contractors with the Goods & Services Register for the Project leading up to and during construction.
- We will hold project information sessions for suppliers once a final investment decision is made on the project and our contractors are appointed. The sessions will invite all local suppliers to attend information sessions to enquire about what goods and services opportunities will be available for them to bid for.
- Estimated 250 jobs during the construction phase
- Estimated 10 full-time jobs during operations

Benefit Sharing Plan

We are committed to sharing the benefits of the Rye Park Wind Farm with the local community and invite you to share your ideas on how we could contribute to meaningful projects that have positive and lasting benefits for many. We will take your feedback into consideration as we move to refine and determine a formal Benefit Sharing Plan in Q1 2021.

- Project suggestions that we receive and are unable to include in the Benefit Sharing Plan will be passed on to CEF committee, once established.
- Tilt Renewables will always be represented by a company-nominated representative on the CEF Committee.

We will share details of the programs which form final BSP with the community after the project reaches FID.

Voluntary Planning Agreement

Tilt Renewables has committed to no less than the total amount of funding that was agreed under the Voluntary Planning Agreement, based on 92 turbines (built and unbuilt).

\$230,000 each year (adjusted by CPI) will be distributed to the community as part our BSP.

Following the commencement of construction, expressions of interest to be part of the CEF Committee will be advertised by the three involved local councils when the Project is nearing construction completion.

Once the wind farm has achieved a construction certificate, Tilt Renewables will contribute the above amount per year to the CEFs for the Project's operating life.
